- VII. **Presentation – Sergeant Doug Gettmann, Pinellas County Sheriff’s Office Alternative Sentencing Unit**
 - Sergeant Gettmann presented 5 programs for pre-trial court sanctions
 1. Day Reporting - Do community hours instead of jail time. Every 8 hours of service takes a day off their time.
 2. Cam Unit - Continuous alcohol monitoring, it is worn on the ankle and picks up excretions from skin.

3. Remote breath- They blow in machine and it takes pictures of them doing it for verification.
 4. GPS – Tracking device used so they stay away from certain zones (victim home, school, work). Officers can call the device if needed.
 5. Supervised ROR (released on own recognizance) – Check in process.
- Programs help with jail overcrowding and expense to the community.
