REMEMBERING

In 2022, these four women tragically lost their lives at the hands of someone who was supposed to love them. This report honors their memory and is an effort to prevent future tragedies.

FOREVER CHANGED

A child left behind after the murder of a parent, a new partner murdered by an ex-partner, a mother left grieving, the neighbor who reported a disturbance, and the emergency responders who arrived on scene are only a few of the people whose lives are tragically affected by intimate partner homicide.

The devastation of intimate partner homicide not only impacts the victim, the entire community is forever changed.

What does it look like to be forever changed? It looks like the child who grows up without a parent and spends their entire life coping with the grief and loss. It looks like the emergency responder who now lives with posttraumatic stress disorder after working the crime scene. It looks like the family member who now questions whether they did everything they could to possibly prevent this. It looks like the prosecutor who spends years fighting in court for justice. It looks like the clergy who is left wondering if they could have intervened more actively. It looks like the neighbor who struggles with the remorse of having not reached out when they saw the bruises or heard the screaming. It looks like the coworker who has nightmares about the day the abuser came to the workplace to threaten everyone and then killed their colleague. It looks like the family and extended family of a victim who is left grieving and trying to understand why, while missing their loved one at every holiday and milestone.

These community members will never be the same. They will continue to deal with the devastation of intimate partner homicide for the remainder of their lives.













TRENDS

The Pinellas Fatality Review Team reviews intimate partner deaths in an effort to learn from each one and prevent further tragedies. Between 2000 and 2022, our team reviewed 177 cases. Because we understand there are numerous facets to a case, it is important to note that we are limited by the available information provided by Fatality Review Team members and their access to that information. Also, while we track national trends, due to the limitations of information we often are unable to determine if certain factors were in place. From our 177 reviews, consistent patterns have emerged and solidified into what we call trends. The trends we have identified for Pinellas County are on this page. We hope that the community sees recognition of these trends as opportunities to save lives.

NO BATTERER INTERVENTION



In 89% of the cases, the abuser had not attended nor been referred to a batterer intervention program. In 49 (42%) of the cases, the perpetrators had been previously arrested for domestic violence crimes yet only 12 (25%) had been ordered to batterer intervention. Batterer Intervention Programs (BIP) hold batterers accountable and work to make behavioral change.



Only 16% of the victims had filed for an injunction for protection against violence (restraining order). Injunctions restrict contact and make it easier for police to take action.

FIREARM USED

In 47% of the cases and 83% of the homicide/suicide cases, a firearm was used. Abusers who own guns are 5 times more likely to kill their partner.

Only 18% of the cases involved a victim having contact with a domestic violence (DV) center. Victims who have contact with a DV center are less likely to be killed.

SUBSTANCE USE

Abuse of substances was a contributing factor in 71% of the cases. Substance use includes alcohol, marijuana, prescribed medication and synthetic drugs. Substance use in a home with domestic violence increases the chances of lethality.

CRIMINAL HISTORY

In 73% of cases, the perpetrator had a criminal history involving various crimes, that may or may not have included domestic violence charges. In homes where DV exists, any criminal history increases the chance of homicide.



In 71% of cases, friends, family, coworkers, and/or neighbors knew about intimate partner violence. Calling a domestic violence center for information, resources and how to help can save a life.

NATIONAL RISK FACTORS FOR INTIMATE PARTNER HOMICIDE Local and national studies consistently demonstrate that the danger level for the victim is heightened when any of these indicators is present.

- Jealous, possessive behavior
- Controlling behavior
- Separation issues
- Firearm in the home
- Substance use

- Prior threats to kill
- Prior use of a weapon
- Threats with a weapon
- Prior strangulation
- Forced sex
